



CLUB RULES

1. The name of the club is "Shrewsbury Road Runners". Club colours are Oranges with a Black logo.
2. The purpose of the Club is the promotion of physical and mental well-being through running.
3. The meeting times and venues of the club are as follows:
Monday 6.30pm – Roman Road Sports Centre, situated in Meole Brace School car park.
Wednesday 6.30pm – Salop Nalgo Centre situated in Shirehall car park
Thursday 6.30pm – Salop Nalgo Centre situated in Shirehall car park (January – April only)
Sunday 9.00am – Various locations (Venue to be announced each Monday)
The aforementioned times and venues are subject to change as circumstances require and will be announced at Club meetings or on the Clubs WhatsApp Group.
4. Membership of the Club and acceptance of these rules will be evidence by the payment of a membership fee (currently £10*) due on 1st April each year.
(*members joining after the following 1st January £5.)
5. Persons wishing to become members will be permitted to run with the Club at the above times, subject to a maximum of four consecutive weeks, whichever shall occur first, after which they will be invited to join the Club.
6. The membership fee is applied primarily for the provision of Club public Liability and third party insurance and minor administration costs. Members are invited to inspect the policy (copies are available on request) to ensure it complies with their needs. The Club makes no representation or warranty that the insurance cover is either adequate or fit for purpose.
7. Apart from the provision of Insurance, as referred to in the previous paragraph, the Club accepts no responsibility for members safety or well-being and all members shall run entirely at their own risk so far as permitted by law, there being no intention to create any form of legal relations in connection with the Club or its administration thereof.
8. Members will comply with all reasonable requirements of the Club in respect of running attire and general behaviour.
9. Any member bringing the Club into disrepute or otherwise behaving unsatisfactorily shall have their membership terminated forthwith but there shall be under no circumstances ant refund or membership fee, either following termination of membership or generally.
10. Changes to the Club rules including the appointment of a Club Leader, shall be made informally by a simple majority show of hands prior to a Monday night session and shall be recorded in writing in the Minute Book. In the event of a dispute over the Club Rules or other matters appertaining to the Club, the decision of the Club Leader (except for the appointment of a new Club Leader) shall be final and binding on all members.
11. A committee of Club members has been appointed to assist the Club Leader and all such appointments shall reviewed at a time to be agreed. Details of the committee members will be available on the Club Website.
12. The Club shall maintain a Bank Account at Barclays Bank into which the membership fee, and any other income monies, shall be paid, and, out of which, Club expenses shall be discharged. Formal accounts will not be prepared but resume of the Club's general financial position will be presented each year to the members.
13. Shrewsbury Road Runners is not affiliated to UK Athletics and fully paid up members of the Shrewsbury Road Runners Club who enter UK Athletics supported events must declare themselves as "unattached" and pay the unattached race fees.
14. Where race entries allow Club names to be declared, fully paid up members of the Shrewsbury Road runners Club can enter under our Club name, run in our Club colours, and pay the appropriate race fee.
